

War Liability: The limit of Insurer's liability in respect of the coverage provided by this endorsement shall be a sub-limit of \$50,000,000. or the applicable policy limit, whichever is less, any one occurrence and in the annual aggregate except with respect to passengers, to whom the full policy limit(s) shall apply. This sub-limit shall apply within the full policy limits(s) and not in addition hereto.
