

The captioned policy includes the following:

1. The “**Who’s covered**” section of “**Your Liability Coverage**” is extended to include **the certificate holder as evidenced by the “Named Insured’s” records**, but only with respect to:
 - a. aircraft owned, managed or operated by **Western Air Charter Inc. DBA Jet Edge, et al** and insured under this policy;
 - b. claims for bodily injury, mental anguish or property damage.
2. We won’t cover **the certificate holder** for claims arising out of their liability as a manufacturer, seller, handler, distributor or service facility of any product or service sold, handled, distributed or provided.
3. The “**Rights against third parties**” section of your policy shall not apply to **the certificate holder** with respect to operations conducted by you.
4. If we or the Aviation Managers make a material change or cancel your policy, we agree to give thirty (30) days notice [ten (10) days in the event of cancellation due to non-payment of premium or seven (7) days or shorter period as may be customary in the case of War Risks Insurance] before the cancellation date or the material change becomes effective, to any charter broker(s) and/or charter customer(s) identified in the USAIG Certificate(s) of Insurance issued by the Aviation Managers.

However, the “Cancellation” provisions stated above shall not be less than the required statutory limits.

5. This insurance is primary and without right of contribution against any other insurance carried by or on behalf of **the certificate holder as evidenced by the “Named Insured’s” records**. However, if there is any other insurance covering the loss that is also covered by this policy and: a) such other insurance is not issued to **the certificate holder as evidenced by the “Named Insured’s” records**; and b) such other insurance is written through the Aviation Managers, the "Limit of Coverage" that applies under your policy will be reduced by the "Limit of Coverage" under such other insurance.
