

FLIGHT QUOTE - TERMS AND CONDITIONS

DEFINITIONS Parties refers to the two parties who are entering into this agreement are "Charterer" and "Charter Company." Charterer refers to the individual or entity requesting the charter service. Charter Company refers to the company providing the service known as "Aircraft Management Group, Inc." and also known as doing business as "AMG Jets."

GENERAL This charter quote is aircraft and flight date/time specific. Any change of aircraft or flight date/time may vary flight costs accordingly. Charterer shall be informed of any such change prior to flight and the amount of additional cost, if any. The quote is based upon aircraft and crew availability. Upon acceptance of terms and conditions listed herein, this document becomes a legal and binding contract between the two parties.

PRICES AND PAYMENTS All prices quoted herein are in US Dollars, accurate on the date quoted, subject to change without notice, and are valid for 48 hours. Full payment is due in US Dollars one business day prior to flight. Regardless of the desired form of payment, Charterer is required to provide valid credit card information as per the Credit Card Authorization section of the Flight Quote. A copy of the front and back of the credit card as well as the card holder's driver's license (or passport) is required for signature verification purposes. Where payment terms are granted by Aircraft Management Group, Inc. d.b.a. AMG Jets to Charterer, the Charterer agrees to authorize credit card funds equal to the flight quote total and minus any discount received in anticipation of receiving cash payment. Aircraft Management Group, Inc. d.b.a. AMG Jets accepts the following payment methods:

- **Credit Card.** Aircraft Management Group, Inc. d.b.a. AMG Jets accepts credit cards issued by Visa, Mastercard, Discover and American Express. **Payments by credit card will be charged a 4% credit card fee.** A copy of the front and back of the credit card as well as the card holder's driver's license (or passport) is required. If payment is to be made by credit card, Aircraft Management Group, Inc. d.b.a. AMG Jets will authorize the credit card immediately upon signature for the full amount of the charter cost plus the 4% credit card fee and will subsequently charge the credit card within 5 business days prior to flight time.

- **Wire Transfer.** Aircraft Management Group, Inc. d.b.a. AMG Jets accepts payment by wire transfer. Funds must be received by Aircraft Management Group, Inc. d.b.a. AMG Jets at least 1 business day prior to flight time. If payment is made by wire transfer, the wire transfer should be made to Aircraft Management Group, Inc. as per the following instructions: Bank Name: PNC Bank; City: Pittsburgh; State: PA; ABA Routing #: 043-0000-96; Account #: 1022869799; and Account Name: Aircraft Management Group, Inc. The SWIFT CODE for international wires is PNCCUS33.

- **ACH Transfer.** Aircraft Management Group, Inc. d.b.a. AMG Jets accepts payment by ACH transfer. Funds must be received by Aircraft Management Group, Inc. d.b.a. AMG Jets at least 1 business day prior to flight time. If payment is made by ACH transfer, the ACH transfer should be made to Aircraft Management Group, Inc. as per the following instructions: Bank Name: PNC Bank; City: Pittsburgh; State: PA; ABA Routing #: 043-0000-96; Account #: 1022869799; and Account Name: Aircraft Management Group, Inc.

CANCELLATION Round-trip flights are subject UP TO a maximum 50% cancellation charge if the flight is canceled within 3 days of flight time and a 100% cancellation charge if canceled within 24 hours of flight time. One-way and Holiday flights (from two days prior to US National, Federal and Bank holidays including US observed religious holidays through two days after US National, Federal and Bank holidays including US observed religious holidays) are subject to an immediate 100% cancellation charge after acceptance of the quote. For partial completion of flights due to Charterer cancellation, the full amount of the charter cost will apply. A No Show will be charged the full amount of the charter cost.

DOCUMENTATION Photo IDs are required prior to flight. Additionally official travel documents (passports, visas, etc.) are the responsibility of each passenger.

ITINERARY CHANGES AND TRANSMITTAL OF CHANGES Itinerary changes are permitted, but subject to aircraft and crew availability and price adjustment.

LATE PASSENGER POLICY Changes made to the departure time may incur additional costs as needed. If client/passenger(s) fail to arrive within one hour of the scheduled departure time, the itinerary will be subject to cancellation by Aircraft Management Group, Inc. d.b.a. AMG Jets and will be subject to the cancellation policy prescribed above.

INCLEMENT AND WINTER WEATHER - ADDITIONAL CHARGES Unless otherwise stated, this quote DOES NOT INCLUDE unscheduled overnights, additional flight time due to diversion for weather, DE-ICING charges, HANGAR rental charges or other reasons beyond the control of Aircraft Management Group, Inc. d.b.a. AMG Jets due to inclement weather.

RESPONSIBILITY; GENERAL RELEASE The Charter Company and its affiliates and their respective officers, directors, partners, shareholders, members, managers, employees, agents, successors and assigns, and all other persons or entities receiving a direct or indirect financial or other benefit from or arising out of the aircraft charter governed by this charter agreement (the "Releasees") shall not be liable for, and Charterer (for and on behalf of Charterer and Charterer's heirs, successors and assigns) hereby fully and forever releases and discharges the Releasees from, any and all injuries, deaths, damages, losses, expenses, claims, actions, suits, causes of action, controversies, and liabilities of every nature and kind, in law, equity or otherwise, whether at this time known or suspected, unknown or unsuspected, anticipated or unanticipated, arising out of or relating to defects in the aircraft that is the subject of this charter agreement, negligence of any Releasee in connection with such aircraft, accidents involving such aircraft, flight delays or cancellations, or Charterer's use of such aircraft. Each Releasee's liability under this charter agreement shall in any case be limited to the amount paid to such Releasee by Charterer.

MECHANICALS Aircraft Management Group, Inc. d.b.a. AMG Jets is not liable for expense incurred for replacement transportation in the case of mechanicals (in such cases our charges apply only on portions of flight completed). If a flight does not reach its destination due to weather, charges apply to any destination reached and return flight of the aircraft and crew (with or without passengers) to home base. In the case of mechanicals, Aircraft Management Group, Inc. d.b.a. AMG Jets may at its option provide substitute transportation which shall be charged as an additional fee to charterer. In such cases, the original charges apply only on portions of flight completed.

OPERATIONAL Aircraft owned or leased by Aircraft Management Group, Inc. d.b.a. AMG Jets are operated under FAA Part 135 Air Carrier Certificate #3CMA159M. Contracted aircraft are operated under their respective Air Carrier Certificates, in which case Charterer shall hold harmless and shall indemnify Aircraft Management Group, Inc. d.b.a. AMG Jets against any and all losses.
