TERMS & CONDITIONS

The following terms and conditions shall apply upon the Purchaser signing and dating the acceptance of this quote. (initial)_____

RIGHT OF REFUSAL

Flightpath Charter Airways may refuse carriage of cargo, baggage, or luggage that, in its sole discretion acting reasonably, and without limitation, is hazardous, unsuitable, poses a risk to the safety of flight, or has an aggregate value in excess of one hundred dollars (\$100,000). Flightpath may prohibit any unruly passenger from initiating or continuing on any flight if, in the sole judgement of the aircraft Captain, the passenger poses a risk to the safety of flight, aircraft equipment, or persons.

CLIENT RESPONSIBILITY

Client shall ensure suitability of all passengers for the proposed travel, including individual health and physical comfort on the chartered aircraft, and possession of proper travel documents. Flightpath Charter Airways will not be liable or in any way responsible for cancellation or delays caused by the Client's failure to ensure suitability of any passenger.

Client shall be responsible for loss or damage to the aircraft or other property on-board the aircraft, included without limitation all expenses, claims, liabilities and/or actions associated therewith caused by or attributable directly to the client, its passengers, employees, family members, associates and/or cargo.

DANGEROUS GOODS

Flightpath Charter Airways does not transport items classified as dangerous goods such as: firearms or explosives, compressed gas cylinders, flammable material, poisons, lithium batteries, oxidizing material, corrosives, paints, radioactive material. It is the responsibility of the client to ensure such items are not presented for transport by the carrier.

FORCE MAJEURE

Flightpath Charter Airways may cancel or delay any charter flight(s) anticipated under this agreement without being liable to pay any cancellation fee or compensation whatsoever in the event that the charter flight(s) cannot be performed or completed due to any cause beyond the control of Flightpath Charter Airways including, but not limited to, acts of God, civil unrest, floods, storms, quarantines, breakdowns or accidents to the aircraft, or if the safety of passenger and/or property is deemed to be in jeopardy by the aircraft Captain or Flightpath Charter Airways, Chief Pilot. In such cases of cancellation or delay, Flightpath Charter Airways shall under no obligation por liability to the Client beyond refund of the agreed cost of that portion of the charter flight(s).

PAYMENT POLICY

Unless credit is established in advance, Flightpath Charter Airways requires a non-refundable deposit of 20% of the quoted cost of the charter flight upon acceptance by the Client, and the entire balance of the quoted cost at least five (5) business days prior to the commencement of flight. Flightpath Charter Airways also requires that a credit card be kept on file for incidental charges, such as catering, flight phone, wi-fi, deicing, hangar storage, ground transportation, etc., and the Client gives Flightpath Charter Airways unconditional authorization to debit this card for any incidental charter charges, there is a 4% convenience fee for all credit card transactions. CANCELLATION

All one-way/empty leg charters are subject to a cancellation fee of 100% of the quoted cost of the flight.
