Terms and Conditions:

GENERAL:

Your flight has been confirmed for the above date(s) and time(s). By signing below, you are hereby confirming the flight for the date(s) and time(s) specified, and accepting the terms and conditions herein. Marc Air will make every effort to be

flexible around our customer's schedule, however, please be advised that your aircraft may be scheduled for flights either

prior to or following your flight. Should it appear that you are going to be delayed, please contact Marc Air as soon as

possible so that we can attempt to mitigate any schedule conflicts.

Marc Air reserves the right to cancel or reschedule flights due to adverse weather conditions or other operational limitations,

including, but not limited to, mechanical failure, acts of nature or other forces majeure which can only be determined the

day of scheduled flight. In no event will Marc Air's liability exceed the Net FLIGHT TIME CHARGES, and Marc Air is not

liable for consequential or incidental damages of any type.

The quote is based upon aircraft and crew availability and is valid for 30 days. Upon acceptance of terms and conditions

listed herein, this document becomes a legal and binding contract between the two parties. Should any dispute arise, it is

agreed that San Luis Obispo will be the proper venue for resolution. This form will be kept on file and it is agreed that it's

terms and conditions will apply to this and all future flights.

PRICES, PAYMENTS AND CANCELLATION

All prices quoted herein are ESTIMATES based on standardized calculations for the trip requested. Final billing will be

based on actual aircraft FLIGHT TIME incurred, including 6 (six) minutes for each take-off and landing ground-taxi. This

includes any increases in FLIGHT TIME above the quoted estimate due to air traffic control delays or diversions to alternate

airports due to weather. However, customers will not incur additional flight charges for take-off delays while on the ground

due to air traffic control. Aircraft de-icing if necessary is not included in this quote and costs to complete de-icing of the aircraft can

vary according to location and conditions.

All charges are due upon receipt of the Marc Air invoice for the specified flight by cash, check, money order, or wire

transfer, unless other arrangements have been approved by Marc Air. By signing below, you hereby agree to be

responsible for any additional charges resulting from changes to the itinerary, including, but not limited to, additional flight

time, landings, overnights, and/or pilot standby time. All incidentals including, but not limited to, ground transportation,

catering, flight-phone, lodging and/or landing fees will also be billed upon completion of the flight.

Customer and/or booking

party (broker) is financially responsible for any physical damage caused to the interior or exterior of the aircraft caused by

customer.

In the event of cancellation, Marc Air requires 48 hour advance notice to cancel the flight without penalty.

Cancellations

received with less than 48 hours notice will be assessed the greater of 25% of quoted FLIGHT TIME charges, or two flight

hours in the confirmed aircraft. If the aircraft departs for a repositioning leg before cancellation notice is

received, customer
will be charged the full flight time charges from the quote.
