### DEFINITIONS

Parties - The two people who are entering into this agreement are "Charterer" and "Charter Company."

Charterer - The individual or entity requesting the charter service.

Charter Company - The Company providing the service known as "New World Aviation, LLC"

### GENERAL

This charter quote is aircraft specific; should the need arise to change aircraft, cost may vary accordingly.

Charterer shall be informed of any such change prior to flight and the amount of additional cost, if any. The quote is based upon aircraft and crew availability and is valid for 30 days. Total amount is based on the Charter Company's selection of FBO's. Upon acceptance of terms and conditions listed herein, this document becomes a legal and binding contract between the two parties.

### PRICES AND CANCELLATION POLICY

All prices quoted herein are accurate on the date quoted, are subject to change without notice, and are valid for 30 days. This quote is all-inclusive with the exception of incidental charges such as, but not limited to, catering, ground transportation, deicing, hangar rental, and flight phone usage.

Additional fees may apply if the client opts to choose an FBO other than New World Aviation's preferred FBO.

For US domestic flights our cancellation policy is as follows: Upon Confirmation this Charter is fully refundable upon booking with the exception of actual costs incurred., I.E. non-refundable hotels, etc. Within 48 hours of departure (including position legs) 2 hours of flight charges plus all actual expenses incurred. For international trips the cancellation policy is 4 hours of flight charges if cancelled within 72 hours of departure (including position legs). Any incidental fees such as, but not limited to airline tickets, hotel costs, and international costs that cannot be recovered will be billed to the Client.

100% cancellation fee applies to all one way itineraries/routings at the time of signing. Availability may be contingent on other scheduled flights. Charter Company will not be held liable if aircraft becomes unavailable after confirmation. If Charter Company cancels scheduled charter, cancellation fee will no longer apply to Charterer.

Holiday Periods are from December 21 - January 6 and the following cancellation applies.

Upon Booking Charter 10% of charter cost plus all actual expenses incurred

Within 10 Days Of Charter 10% or 3 hours of flight charges, whichever is greater, plus all actual expenses incurred

72 Hours Prior To Charter 4 hours of flight charges or 10%, whichever is greater, plus all actual expenses incurred

### ITINERARY CHANGE and TRANSMITTAL OF CHANGES

Itinerary changes are permitted, but subject to aircraft and crew availability and subject to price adjustment.

Notification of changes and/or cancellations must be called into New World Aviation, not to crew members. In the case of a change to itinerary, this quote and pricing no longer applies and new paper work will need to be signed prior to departure. Charterer only owns legs indicated with passengers greater than zero. Requests to fill these position legs will require a new quote signed and subject to availability / possible rate increase / and new owner's approval if required.

### RESPONSIBILITY

Charter Company shall not be liable for any injury, damage, loss, expense, indirect, special, or consequential damages, or other irregularity caused by the defect of any vehicle or conveyance, or the negligence of any third party engaged in conveying the passenger or carrying out with arrangements for your trip or by accident, delay, flight schedule, change, cancellation, sickness, weather, strikes, war, quarantine, or any similar cause. To the extent permitted by applicable law, our liability shall in any case be limited to the amount paid to us, and any claim shall be adjudicated in and governed by the laws of the state of California.

### PARTIAL COMPLETION OF FLIGHTS

If a flight does not reach its destination due to weather or a mechanical interruption, Charterer agrees to pay charges for the completed portion of the trip. New World Aviation will make every effort to locate a suitable alternative, but cannot guarantee the price of the alternate aircraft.

### OPERATIONAL

Aircraft owned or leased by Charter Company are operated under FAA part 135 Air Carrier Certificates #N38A138Y, contracted aircraft are operated under the respective FAA Part 135 Air Carrier Certificates, in which case Charterer shall hold harmless and indemnify Charter company against any and all losses. Operational control and communication will be maintained by the Charter company and crew personal contact information and will not be given out. Government issued photo ID's are required prior to flight. Additionally official travel documents (passports, visas, etc.) are the responsibility of each Passenger. ### ADDITIONALLY BILLABLE ITEMS

De-Icing charges or hangar fees incurred in order to prevent De-Icing while on a charter with the Charterer. Flight Phone Usage by passengers. Damage beyond normal wear and tear caused by passengers. Smoking Fee applies if smoking is permitted. VIP handling services requested by passengers at international locations. Catering beyond Standard stock and passenger ground transportation paid for or arranged by the Charter Company.
