TERMS AND CONDITIONS

Charter Quote

Pegasus Elite Aviation, Inc. (hereinafter referred to as "PEA") agrees to provide aircraft charter services to the above named client in accordance with the attached schedule and the price quote stated. This quote is valid for 14 days from day of receipt and is based upon aircraft and crew availability. PEA does not guarantee tail numbers on one-way trips, only the aircraft type is guaranteed. Pricing does not include the following: catering, transportation, flight phone and WIFI usage, any damage to the aircraft, additional flight time due to adverse weather conditions, additional International fees, additional landings, ramp, hangar or de-icing charges. PEA does reserve the right to adjust the fuel surcharge amount on quotes booked more than 14 days in advance due to current market conditions. APU usage for 1 hour before and 30 minutes after each flight is at no cost. Excess APU usage due to passenger delay will be billed to customer at \$350.00 per hour. A fee of \$450.00 may be applicable for smoking and pets. PEA will select FBO's at each airport on this itinerary. If customer requests a particular FBO, a surcharge may be applicable and will be added to this quote. UK APD will be applicable on all flights departing the UK at a rate of \$724.20 per person with an additional processing fee of \$119.00 per trip.

To confirm an aircraft booking, PEA must receive this signed contract with a legible copy of the credit card (front and back) and a valid ID reflecting the name on the credit card. Signature on this agreement must be the signature of the carholder. All pertinent paperwork must be sent to consider the aircraft booked. PEA is authorized to keep credit card details on file for charges associated with this trip and any other outstanding balance.

Payment Terms

Payment terms are full prepayment prior to departure for all charter trips, including one-ways and international trips unless prior arrangements have been made. If payment is not received within the specified payment terms, PEA is authorized to charge the given credit card for the full amount in addition to a 5 % administrative fee. If wiring up front then no administration fee will apply. All segment fees and FET will be paid by the broker/agent or client, unless noted otherwise. This quote serves as an invoice for payment prior to trip departure. A final invoice will be provided post flight to include any additional charges.

FEDERAL EXCISE TAX EXEMPTION CERTIFICATE

Seq., of the International Revenue Code of 1986, as amended (or any successors statutes or provisions), and that Pegasus Elite Aviation, Inc. shall be exempt from having to collect, account for and pay over to any person, entity or governmental agency any of the foregoing taxes and fees.

The undersigned further acknowledges and agrees that (i), in connection with the Flights, the undersigned is not an agent of Pegasus Elite Aviation, Inc.; and (ii), the undersigned will provide to Pegasus Elite Aviation, Inc., upon written request, evidence of the undersigned's collection and payment of taxes and fees.

This certificate shall remain in full force and effect between the parties for all trips completed during the calendar year.

Cancellation Policy

Our cancellation policy for flights within the Americas is 50% of the quote if the flight is cancelled within 48 hours of departure time and 100% of the quote if cancelled within 24 hours of departure time. Our cancellation policy for all other international flights is 50% of the quote if the flight is cancelled within 72 hours of departure time and 100% of the quote if cancelled within 48 hours of departure time. Our cancellation policy for all domestic and international one-ways is 100% upon booking unless prior arrangements have been made. A no show will be charged the full amount of the charter cost.

Peak travel day policy is as follows: If cancelled within 7 days to 72 hours of the departure time of the scheduled flight, the cancellation policy is 2 flight hours. If cancelled within 72 hours of the departure time of the scheduled flight, the cancellation policy is 100% of the quote. A no show will be charged the full amount of the charter cost. Peak travel days are November 19 -November 27, December 17-January 7 and February 14-February 19.

Responsibility

PEA is not liable for any injury, damage, loss, expense, special or consequential damages, or any other irregularity caused by the defect of any vehicle or conveyance, or the negligence of any company or person engaged in conveying the passenger or carrying out the arrangements for your trip or by accident, delay, flight schedule, change, cancellation, sickness, weather, strikes, war, quarantine, or any similar cause. PEA's liability shall in any cause be limited to the amount paid to us, and any claim shall be, adjudicated in and governed by the laws of the State of California in which we have our principle business location.

PEA is not liable for expenses incurred for replacement transportation in the case of mechanicals. In the case of mechanicals, PEA will try to supply a substitute aircraft of similar cabin-class if available. In the case one is not available, the original aircraft specific quote will not be considered valid and pricing may increase.
