



CHARTER AGREEMENT

GENERAL Prices contained within this quote are best estimates for related services at the time of the request and are valid for 30 days. Your authorized signature on this document will serve as confirmation for the route and aircraft specified under Quote Number 7891.

ADDITIONAL SERVICES You/your company assumes financial responsibility for the grand total amount quoted PLUS any charges incurred by passengers for changes in routing, additional landing or international handling fees, special requests, flight phone, internet service, catering or ground transportation. Phone and internet charges are based on data usage which may be difficult to determine in advance of the flight. Ground services such as hangar or de-icing fees, as deemed necessary by the flight crew for the safety flight, will be the responsibility of the client.

DAMAGE TO AIRCRAFT Client will pay for all reasonable costs and expenses to clean, repair or replace any property or cabin fixture damaged due to the negligence or misconduct of Client or passengers (normal wear and tear excepted.) Damage not considered normal wear and tear shall include, but is not limited to, such items as: upholstery stains, broken plate/glassware, broken drawers, torn seats or headliner, food or drink spills which require professional assistance. While pets may be allowed on a case by case basis, they must be kenneled or restrained for safety of flight purposes and the Client is responsible for resulting damages or stains. Smoking is generally prohibited except under special circumstances in which case the Client will be responsible for the associated cleaning fees of the aircraft interior.

Unless otherwise stated on the quote, CANCELLATION TERMS are as follows:

1. Cancellation of a domestic trip during non-holiday periods and within 4 business days of the scheduled departure are subject to a charge of 25% of the quoted amount. Within 2 business days of the scheduled departure are subject to a charge of 50% of the quoted amount. Within 24 hours of the scheduled departure are subject to a charge of 100% of the quoted amount.
2. Cancellation of an international trip during non-holiday periods within 14 business day of the scheduled departure are subject to a charge of 50% of the quoted amount. Within 7 business days of the scheduled departure are subject to a charge of 75% of the quoted amount. Within 2 business days of the scheduled departure are subject to a charge of 100% of the quoted amount.
3. Holiday periods are defined as the three business days prior to, through the three business days following, President's Day, Memorial Day, Independence Day (July 4th), Labor Day, Thanksgiving, Christmas, and New Year's Day. The following will apply to cancellations of trips scheduled during holiday periods. Cancellations within 14 days of the scheduled departure are subject to a charge of 50% of the quoted amount, or 4 hours of flight time at the quoted rate, whichever is greater. Cancellations within 7 days of scheduled departure are subject to a charge of 100% of the quoted amount.
4. Cancellation of any one-way itinerary, including multi-leg routes, at any time after confirmation, will be subject to a charge of 100% of the quoted amount
5. In addition to cancellation charges, all cancellations, regardless of when they occur, are subject to payment of any actual expenses incurred by Solairus.

DELAY, DIVERSION, OR TERMINATION OF TRIP Client acknowledges and agrees that a charter trip may be delayed, diverted, or terminated under certain circumstances, including but not limited to adverse weather conditions, operational limitations, mechanical failure or a Safety of Flight determination. The pilot-in-command of the aircraft will be in complete charge and control of the aircraft at all times. If, in the pilot-in-command as sole judgment, safety of flight may be jeopardized, then he/she may terminate or refuse to commence a flight (a Safety of Flight determination). Except for a delay, diversion, or termination caused by the Client or any passengers, if a trip is delayed, diverted, cancelled, or terminated prior to completion, including because of a Force Majeure or Safety of Flight determination, then Client will only be charged for the cost attributable to transportation actually performed and such transportation as may be necessary to return charter passengers to their original airports of departure, if they so elect to return. If Client requests that Solairus arrange for a replacement charter aircraft to complete Clients scheduled itinerary, Client agrees to pay for such replacement aircraft costs, including any additional cost for positioning the replacement aircraft to or from Clients departure or arrival location.

PAYMENT Payment is due in advance of the date of travel unless other arrangements have been agreed to in writing by Solairus Aviation. The quoted price includes a cash-discount of 5%, which will not apply for accounts settled by credit card. Charges not paid when due will accrue interest at 15% per annum and a collection fee assessed at 5% of the unpaid balance. With your authorized signature, you hereby agree to be responsible for any additional charges resulting from changes in the itinerary, additional flight time, landing fees, overnights, standby, actual international fees incurred, and other flight related charges. All additional services arranged on behalf of the client will be billed upon completion of the flight.

INTERPRETATION AND LAW This Agreement will be governed by the laws of the State of California.

OPERATIONAL All passengers are required to provide a valid form of photo ID prior to each flight. Aircraft are operated under FAA Certificate# 7SSA382M or the respective carrier certificate for any contracted aircraft. Client represents that it is (i) the end user of the charter, (ii) a direct air carrier or commercial operator certificated by the FAA to engage in part 135 operations using the specified aircraft or any contracted aircraft or (iii) acting as agent for a person or entity described in clause (i) or (ii).

TERMS AND CREDIT CARD AUTHORIZATION Solairus Aviation is authorized to use the credit card number listed below to settle any outstanding balance not paid within the agreed payment terms as outlined above. Should it be necessary to utilize the indicated credit card to collect charges, the balance will be adjusted by the amount of the cash discount.
