Baggage limitation:

Cessna C56X Excel (OE-GXL) and Phenom 300 (OE-GDP, OE-GDF & OE-GPL): max 300 kg loadable, preference with soft bags (max 25 kg by piece) or small hard suitcase (max 25 kg per piece). Maximum size of baggage would be length 80 cm, width 59 cm and height 40 cm. Skis are accepted on board with special limitation.

Cessna C25A CJ2, C55B Bravo and C560 Ultra (OE-FXM, OE-GCH & HB-VNA) : max 130 kg loadable, preference with soft bags (max 20 kg by piece) or small hard suitcase (max 20 kg per piece). Maximum size of baggage would be length 70 cm, width 50 cm and height 32 cm. Skis are not accepted on board.

Data relative to baggage could vary by the number of passengers on board.
